This section of the Membership Form ensures that our Scout Group complies with existing legislation regarding the use and retention of personal data.

- i. Contact details such as address and telephone number
- ii. Progress Records – information relating to the training given by the Scout Association of Malta and attained by the child.

The medical information given overleaf is used by the Leaders in charge to assess whether specific activities are suitable for our members and so that they have a point of reference should an accident take place. Medical information is kept confidential and is only disclosed on a need-to-know basis. This relates to information about medical conditions, both physiological and psychological, that your child has been diagnosed with.

Photos and Video are an essential part of the operation of a Scout Group because they allow us to keep visual evidence of our activities and track the history of the Section. The bulk of this material is kept on archive for internal use like logbooks, however we sometimes choose some photos to be published for newspaper/magazine articles or for our website. In all cases, the photos/video kept and published is carefully screened to ensure that it is suitable. If you have a doubt about this, feel free to visit www.sliemascouts.net, and see for yourself!

Photographs (digital and printed) and videos that may be held in albums/ log books/ frames/ library and which may be used in the media or on the Section/Group/Association's Website. It is important to note that all information given in this Membership Form will not be divulged to third parties outside the Scout Association of Malta. In the case of photographs and video, it is our policy that:

- a. Your child will always be shown wearing decent attire and found in a reputable pose.
- b. That your child's full name will not be divulged and that he/she will not be identified in any manner.
- c. That no personal contact details will be published enabling third parties to contact or identify your child.

Each year, the Scout Group collects an Annual Subscription fee from all members. This Annual Subscription Fee is used by the Group to cover the general costs of running a Scout Group like rent, water, electricity, equipment maintenance etc. This fee is separate from the weekly/monthly subscriptions paid by members and which are administered by the respective sections.
